INTRODUCTION

1. Rationale for the Research Topic

For any social regime to exist and develop, it must be built by individuals who are loyal to the regime, possess intelligence, competence, ethics, and, most importantly, political bravery. Over the past 95 years, Vietnam's revolutionary cause under the leadership of the Communist Party of Vietnam has demonstrated that one of the decisive factors behind the country's great achievements and remarkable victories is the steadfast and resolute political bravery (PB) of the cadre and Party members. Their steadfast political courage has shone through as they have led the nation through tough times and pivotal moments in both Vietnam's history and the global revolutionary movement.

Throughout his revolutionary career, President Ho Chi Minh emphasized: "The success or failure of all matters depends on whether the cadres are competent or not. This is an absolute truth". According to his perspective, for the revolution to succeed, cadres must possess both virtue and talent, integrating qualities of character and competence, as well as bravery. These attributes must be concretely demonstrated through their actual performance and the fulfillment of assigned duties. At every critical juncture of the revolution, President Ho Chi Minh and the Communist Party of Vietnam creatively combined Marxist-Leninist theory with Vietnam's revolutionary reality, formulating the correct political direction and setting forth tasks and goals for the entire Party and its cadre.

Deeply ingrained in Marxist-Leninist theory and Hồ Chí Minh's ideology, in response to new challenges and responsibilities, the Communist Party of Vietnam has always prioritized cadre affairs and cadre development, identifying this as the key factor in all revolutionary activities and the determinant of success or failure. Various Party documents affirm the crucial role of cadres in the nation's construction and development. The 3rd Plenary Session of the 8th Central Committee of the Communist Party of Vietnam highlighted: "Cadres play an extremely important role in either facilitating or obstructing the renewal process. Cadres in general hold great significance, and grassroots cadres, in particular, serve as the foundation. The strength or weakness of an organization largely depends on the quality of its cadre team". The Resolution of the 12th National Party Congress further asserted: "Cadres are a crucial factor in determining the success or failure of a revolution. Cadre work serves as the "key" to building the Party and establishing the political system. Therefore, developing a strong cadre workforce, particularly at the strategic level, is the Party's most critical task. This process must be carried out regularly, carefully, scientifically, rigorously, and effectively. Investing in the development of cadres is an

investment in long-term and sustainable growth”. The 13th National Party Congress of the Communist Party of Vietnam outlined key directives for the Party: *“Enhancing political bravery, intelligence, exemplary conduct, and the spirit of serving the people among cadres and Party members, especially key leaders and heads of agencies at all levels”*.

Within the cadre and Party member system, cadres under the management of the Standing Committees of Provincial and Municipal Party Committees play a particularly significant role. Specifically, cadres in the Red River Delta (RRD) under the management of the Standing Committees of Provincial and Municipal Party Committees hold an essential position. They are the key leadership group directly responsible for advising on and implementing the Party’s and the State’s policies at localities, agencies, and units. The Red River Delta, consisting of 11 provinces and cities, holds a strategic position in terms of economy, politics, national defense, and security. In the course of development, one of the fundamental requirements for provinces and cities in the RRD is the establishment of a cadre team, especially key leadership personnel, who possess political bravery, competence, ethical qualities, and professional expertise to meet the demands of the digital era and the nation’s aspirations for growth. In recent years, provinces and cities in the RRD have effectively implemented Resolution No. 54-NQ/TW of the 9th Politburo and Conclusion No. 13-KL/TW of the 11th Politburo on socio-economic development and ensuring national defense and security in the Red River Delta region. These efforts have positioned the RRD as the most developed region in Vietnam, laying a foundation for provinces and cities in the area to successfully implement Resolution No. 30-NQ/TW (dated November 23, 2022) of the Politburo on socio-economic development and national defense and security in the Red River Delta until 2030, with a vision to 2045. The region’s achievements stem from various factors, one of which is the role of cadres at the provincial and municipal levels, particularly those under the management of the Standing Committees of Provincial and Municipal Party Committees. Moreover, in the present phase, when the entire political system (PS) is undergoing reforms in accordance with Conclusion No. 217-KL/TW of the Politburo and Secretariat (dated February 28, 2025) on researching and proposing further restructuring of administrative apparatuses, the effective implementation of these reforms in RRD provinces and cities, as well as their ability to maintain the region’s strategic position, will largely depend on the quality of leadership and management personnel at all levels, from the provincial and municipal levels down to the grassroots. The ability of this cadre group to uphold political bravery (PB) is a key factor in ensuring unity in thought and action, enabling them to remain steadfast in their political stance and ideological beliefs, undeterred by negative external

influences. They must possess the courage to think, act, and take responsibility, the resilience to overcome difficulties and hardships, the determination to face challenges, and the ability to make sound decisions in all situations.

However, in recent years, under the impact of globalization and international integration, along with the rapid development of the internet and social media, numerous challenges have emerged. Negative aspects of the market economy and hostile forces' subversive activities have led to a segment of cadres and Party members—especially those in key leadership positions at various levels—exhibiting signs of ideological decline. More alarmingly, some have deviated from the Party's goals and ideals, lost vigilance against negative influences, and violated Party principles and discipline, even breaking the law. They have been swayed by personal interests, corruption, political maneuvering, luxurious lifestyles, and moral decay, seriously damaging the reputation of Party organizations and shaking public confidence in the Party's reform efforts and socialist development path.

Given these complex developments, one of the urgent requirements is to build a cadre team in general, and specifically cadres under the management of the Standing Committees of Provincial and Municipal Party Committees in the Red River Delta, who possess the competence, qualifications, ethical qualities, and political bravery to effectively “respond to” and adapt to all circumstances.

Based on the above reasons, the author chose the issue: *“Political Bravery of Cadres under the management of the Standing Committees of Provincial and Municipal Party Committees in the Red River Delta today”* as a doctoral thesis in Party and State government building.

2. Purpose and tasks of the thesis

2.1 2. Purpose of the thesis

On the basis of clarifying theoretical and practical issues concerning the political bravery (PB) of cadres under the management of the Standing Committees of Provincial and Municipal Party Committees in the Red River Delta (RRD) today, the thesis proposes orientations and solutions to enhance their PB until 2035.

2.2 Tasks of the thesis

- Conduct an overview of research related to the topic.
- Clarify theoretical and practical issues regarding the PB of cadres under the management of the Standing Committees of Provincial and Municipal Party Committees in the RRD.
- Assess the current status of PB among cadres under the management of the Standing Committees of Provincial and Municipal Party Committees in the RRD from 2015 to 2024, identifying strengths, limitations, causes, and emerging issues on

PB of cadres under the management of the Standing Committees of Provincial and Municipal Party Committees in the RRD.

- Propose orientations and solutions to enhance PB of cadres under the management of the Standing Committees of Provincial and Municipal Party Committees in the RRD until 2035.

3. Research Subject and Scope

3.1. Research Subject

The research subject of the thesis is the political bravery (PB) of cadres under the management of the Standing Committees of Provincial and Municipal Party Committees in the RRD.

3.2. Scope of the research

- *Timeframe*: The thesis focuses on surveying and assessing the PB of cadres under the management of the Standing Committees of Provincial and Municipal Party Committees in the RRD from 2015 to 2024. The proposed orientations and solutions are applicable until 2035.

- *Geographical boundaries*: Provinces and cities in the Red River Delta region include: Hanoi city, Hai Phong city, Quang Ninh province, Hai Duong province, Hung Yen province, Bac Ninh province, Thai Binh province, Ha Nam province, Nam Dinh province, Ninh Binh province, Vinh Phuc province.

4. Theoretical and Practical Basis, and Research Methods

4.1 Theoretical Basis

The thesis is based on the theoretical basis of Marxism-Leninism, Ho Chi Minh's Ideology, and the viewpoints of the Communist Party of Vietnam on cadres, cadre development, and political bravery.

4.2 Practical Basis

The practical foundation of the thesis includes the current state of PB among cadres under the management of the Standing Committees of Provincial and Municipal Party Committees in the RRD, as well as efforts to build and enhance their PB from 2015 to 2024.

4.3 Research Methods

* The thesis is researched on the basis of the methodology of dialectical materialism and historical materialism

* The thesis uses a synthesis of research methods of political science and interdisciplinary science such as: method of summarizing practices; method of combining history with logic; statistical and comparative methods; inductive and deductive methods; sociological investigation methods, etc., in which, the following specific methods are used:

- *Historical and logical combination method*: Applied in Chapter 2 to clarify the theoretical foundation of political bravery (PB) among cadres;

- *Statistical, comparative, inductive, and deductive methods*: Utilized in Chapter 3 to analyze the current state, strengths, limitations, and causes of PB among cadres and to establish key perspectives and proposed solutions for enhancing PB among cadres under the management of the Standing Committees of Provincial and Municipal Party Committees in the RRD from 2015 to 2024.

- *Analytical and synthetic methods*: Based on accessing various sources, including reports from localities, institutions, and relevant research, the thesis extracts, analyzes, and synthesizes information related to the research topic.

- *Sociological survey method*: To support the research, the author designed and conducted two survey questionnaires to assess the current state of PB among cadres under the management of the Standing Committees of Provincial and Municipal Party Committees in the RRD. The collected data was analyzed using SPSS version 22, employing descriptive analysis, reliability assessment, and Cronbach's Alpha reliability coefficient method. The thesis conducted surveys and assessments across provinces and cities in the RRD with details as follows:

- + Survey respondents: Leaders and managers in agencies and units within the political system in provinces and cities of the Red River Delta (from the district level and above), and cadres working in Party-affiliated advisory agencies (from the district level and above)

- + Survey distribution units: The thesis distributed survey questionnaires to key locations, including: Hanoi City: 100 questionnaires; Hai Phong City: 100 questionnaires; Vinh Phuc, Thai Binh, Hai Duong, Bac Ninh, Quang Ninh, and Ha Nam Province: 50 questionnaires/ province. Total number of surveys: 500 questionnaires.

- + Survey period: From June 2024 to November 2024.

5. New Scientific Contributions of the Thesis

- The thesis clarifies the conceptual framework of PB among cadres under the management of the Standing Committees of Provincial and Municipal Party Committees in the RRD, as well as the formation and development process of PB among these cadres.

- It identifies key issues related to PB among cadres under the management of the Standing Committees of Provincial and Municipal Party Committees in the RRD.

- The thesis proposes two breakthrough solutions to enhance PB among cadres under the management of the Standing Committees of Provincial and Municipal Party Committees in the RRD in the coming period: Firstly, clarifying the requirements and

content of PB into the cadre qualification criteria and assessment standards, ensuring they align with the responsibilities of each position and are strictly implemented; Secondly, innovating the content and methods of PB education and training, focusing on political theory updates, PB enhancement, and leadership skills development.

6. Theoretical and Practical Significance of the Thesis

- The thesis contributes to clarifying the concept of PB among cadres under the management of the Standing Committees of Provincial and Municipal Party Committees in the RRD today.

- Its findings can serve as reference materials for cadre development at the provincial and municipal levels in the RRD, contributing to PB enhancement among these cadres

- The thesis can also be used as a reference for research and teaching in Party Building courses within the system of Party schools.

1.3. Overview of the results of research works related to the thesis topic and issues that the thesis focuses on solving.

1.3.1. Overview of the results of research works related to the thesis topic:

Firstly, in terms of theoretical perspectives, domestic and international scientific research has fundamentally analyzed and clarified the concepts of “cadre”, “bravery”, “political bravery”, and the political bravery of cadres, particularly in

relation to their roles, responsibilities, and duties in the current context. A few studies have examined the role of PB, its relationship with other qualities, and the Party's policies on enhancing PB for cadres and Party members.

Secondly, regarding practical aspects, these scientific works have generally provided accurate and relatively detailed assessments of the current state of PB and the efforts to improve PB among cadres and Party members, supported by specific data and examples. Some studies have highlighted experiences in cadre development, including methods for training and fostering PB among cadres and Party members.

Thirdly, several studies have analyzed factors influencing the quality of the cadre workforce. Based on this analysis, they have proposed solutions to improve the overall quality of cadres, including measures to enhance PB among cadres in general and leaders and managers in particular.

1.3.2. Issues that the thesis needs to focus on researching

Firstly, the thesis provides an overview of the characteristics of provinces, cities, provincial and municipal Party committees, and cadres under the management of the Standing Committees of Provincial and Municipal Party Committees in the Red River Delta. It also clarifies the roles and characteristics of these cadres in the current context.

Secondly, the thesis constructs a theoretical framework, including the definition, content, role, and formation process of PB among cadres under the management of the Standing Committees of Provincial and Municipal Party Committees today.

Thirdly, it surveys and evaluates the current state of PB among cadres under the management of the Standing Committees of Provincial and Municipal Party Committees in the RRD, analyzing strengths and weaknesses based on four key PB aspects. It identifies both objective and subjective causes and outlines emerging issues concerning PB among these cadres.

Fourthly, the thesis forecasts influencing factors and proposes directions for enhancing PB among cadres under the management of the Standing Committees of Provincial and Municipal Party Committees in the RRD by 2035. It also suggests and justifies comprehensive, feasible solutions tailored to the regional characteristics and cadre profiles to improve PB among these cadres in the coming period.

Conclusion of Chapter 1

Through a comprehensive review of domestic and international research on the dissertation topic, it is evident that, despite differing approaches, these studies have fundamentally examined and clarified both theoretical aspects and practical experiences related to cadres, political bravery of cadres, and the political bravery of leadership and management cadres.

Chapter 2

POLITICAL BRAVERY OF CADRES UNDER THE MANAGEMENT OF THE STANDING COMMITTEES OF PROVINCIAL AND MUNICIPAL PARTY COMMITTEES IN THE RED RIVER DELTA – THEORETICAL AND PRACTICAL ISSUES

2.1. Provinces, cities, provincial and municipal party committees and cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta.

2.1.1. Provinces and cities; and provincial and municipal party committees in the Red River Delta

2.1.1.1. Characteristics of provinces and cities in the Red River Delta

The Red River Delta, comprising 11 provinces and centrally-run cities, covers 6.42% of the country's area, with about 21,278 km², and has a critical role in politics, economics, culture, society, the environment, defense, security, and foreign affairs of the whole country.

2.1.1.2. Characteristics of provincial and municipal party committees in the Red River Delta

As of December 2024, the two municipal party committees in Hanoi City and Hai Phong have 85 party committees directly under the municipal party committee, with 4,427 grassroots party organizations and 608,455 party members; 09 provincial party committees have 124 party committees directly under the provincial party committee, with 79 municipal, district and town party committees; 45 bloc party committees and equivalent; there are 6,097 grassroots party organizations and 627,649 party members.

2.1.1.3. Provincial and municipal party committees in the Red River Delta

Provincial and municipal party committees (abbreviated as provincial-level party committees) are the leading bodies of provincial and municipal party committees elected by provincial and municipal congresses between two congresses. As of December 2023, the Red River Delta has 09 provincial party committees and 02 municipal party committees, specifically: Ha Nam provincial party committee, Nam Dinh provincial party committee, Bac Ninh provincial party committee, Hai Duong provincial party committee, Vinh Phuc provincial party committee, Thai Binh provincial party committee, Quang Ninh provincial party committee, Ninh Binh provincial party committee, Hung Yen provincial party committee, Hanoi municipal party committee, Hai Phong municipal party committee.

2.1.2. Cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta today - concept, characteristics, role

2.1.2.1. Concept

Cadres under the management of the standing committees of the provincial and municipal party committees in the Red River Delta are key leaders and managers who play important roles in the political system of the province or city. The standing committees of the provincial and municipal party committees directly or jointly implement cadre management contents according to the management hierarchy.

2.1.2.2. Characteristics of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta today

Firstly, cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta are those who hold leadership and management positions in the political system at the provincial, city and district levels, as well as localities, agencies and units; *Secondly*, cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta generally develop from the grassroots or are transferred and mobilized by provincial agencies, and they are trained and tested in practice; *Thirdly*, cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta are cadres with the ability to innovate, be creative, and flexibly adjust to the high demands of the developing socio-economic environment; *Fourthly*, cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta have leadership and management approaches that are shaped by cultural influences of the Red River Delta region;

2.1.2.3 . Role of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta

Firstly, cadres under the management of the standing committees of provincial and municipal party committees are the core forces that directly decide the effectiveness of implementing the Party and State's guidelines, policies, and political tasks in localities, agencies, and units; *Secondly*, cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta are the core force in leading, guiding, and increasing the quality of the provincial and city's political systems in a streamlined manner, working effectively, beneficially, and successfully, satisfying the requirements of tasks in each period; *Thirdly*, cadres under the management of the standing committees of provincial and municipal party committees are the center and nucleus in developing and sustaining

solidarity and unity within the Party and among the people. They set an example in all activities, work, and life in localities, agencies, and units; *Fourthly*, cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta are the bridge between the provincial and grassroots levels in terms of implementing, proposing, and reflecting the application of policies and guidelines in the locality, contributing to the development and improvement of the Party's guidelines, policies, and State laws.

2.2. Political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta - concept, content, role, and path of formation and development of political bravery

2.2.1. The concept of political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta

The political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta is the steadfastness and firmness in political stance; the the independence of thinking, timely decision and action to overcome difficulties and challenges, and determination to perform well the tasks of oneself, of the agency, unit and locality; not to be confused or wavering in the face of difficulties; to be frank and courageous in fighting against wrong political views; to dare to openly recognize mistakes and inadequacies in order to self-correct, and to constantly innovate for progress and maturity of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta.

2.2.2. The content of political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta.

Firstly, cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta are steadfast in the Party's ideals and goals; steadfast in and creatively apply and develop Marxism-Leninism and Ho Chi Minh's Ideology; steadfast in the goals of national independence and socialism; steadfast in the Party's renovation policy; steadfast in the principles of Party building to firmly build and defend the socialist Vietnamese Fatherland; *Secondly*, they are calm and clear-headed while thinking and acting, have autonomous political thinking, are decisive and resolute in action to overcome challenges, and accomplish well assigned duties and tasks; *Thirdly*, they are good examples of self-critique, being open-minded, patiently listening to other people's perspectives, being

confident, daring to think, daring to do, daring to take responsibility, for the common good, not panicking or wavering in the face of challenges in executing tasks; *Fourthly*, they are frank and courageous in fighting against wrong political views; dare to admit mistakes and shortcomings in order to self-correct; constantly innovate to progress and mature; and resolutely and uncompromisingly fight against the sabotage activities of hostile forces that sabotage the Party, the regime, and the revolutionary cause.

2.2.3. The path of formation and development of political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta

Firstly, the political bravery of cadres is formed through the process of training, fostering, education and self-education, especially education on Marxism-Leninism, Ho Chi Minh's Ideology and the state's legal policies; *Secondly*, the political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta is formed through practical activities, including activities of performing personal tasks and Party work activities; *Thirdly*, the political bravery of cadres is formed through the process of self-study and training of the cadre team; *Fourthly*, the political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta is formed through party committees, party organizations, and political systems; the impact of objective factors such as: environment, circumstances, attachment and supervision of the people;

2.2. 4. The role of political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta

Firstly, the strong political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta helps guide the correct and appropriate thinking and actions of cadres and organizations, thereby contributing significantly to creating the quality of the cadre team; *Secondly*, the political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta helps them always stand firm in the face of all difficulties and challenges, and always complete their tasks well; *Thirdly*, the political bravery will help cadres under the management of the standing committees of provincial and municipal party committees have the right perspective in considering, evaluating and handling the situation; *Fourthly*, the political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River

Delta helps them contribute to effectively fighting against hostile thoughts and viewpoints; *Fifthly*, the political bravery also contributes to improving the quality and effectiveness of work in performing the duties and tasks of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta.

Summary of Chapter 2

Cadres under the management of the standing committees of the provincial and municipal party committees in the Red River Delta are key leaders and managers who play important roles in the political system of the province or city. The standing committees of the provincial and municipal party committees directly or jointly implement cadre management contents according to the management hierarchy. Chapter 3

POLITICAL BRAVERY OF CADRES UNDER THE MANAGEMENT OF THE STANDING COMMITTEES OF PROVINCIAL AND MUNICIPAL PARTY COMMITTEES IN THE RED RIVER DELTA - CURRENT STATUS, CAUSES AND ISSUES

3.1. The current status of political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta

3.1.1. Advantages

3.1.1.1 Most of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta steadfastly uphold the Party's ideals and goals; steadfastly apply and creatively develop Marxism-Leninism and Ho Chi Minh's Ideology; steadfastly uphold the goals of national independence and socialism; steadfastly uphold the Party's renovation policy; steadfastly uphold the principles of Party building to firmly build and defend the socialist Vietnamese Fatherland.

3.1.1.2 Most of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta are calm, clear-headed while thinking and acting, have autonomous political thinking, are decisive and resolute in action to overcome challenges, and accomplish well assigned duties and tasks

3.1.1.3 Most of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta are confident, dare to think, dare to do, dare to take responsibility for the common good, and are not confused or wavering in the face of difficulties in performing their tasks.

3.1.1.4 Most of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta are frank and courageous in fighting against wrong political views; dare to admit mistakes and shortcomings in order to self-correct; constantly innovate to progress and mature; and resolutely and uncompromisingly fight against the sabotage activities of hostile forces that sabotage the Party, the regime, and the revolutionary cause.

3.1.2. Limitations

3.1.2.1 A few cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta are still demonstrating indicators of not being fully steadfast and firm in their political.

3.1.2.2 Some cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta are not really

aggressive in their work, displaying signs of being terrified of obstacles and hardships. Their political drive is not really high, resulting to poor results in implementing political tasks.

3.1.2.3 The study of political theory by some cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta is not yet proactive and positive, even largely theoretical, and sometimes lacking in pragmatism, particularly in the abilities of dealing with circumstances in the new scenario.

3.1.2.4 The spirit of frankness, courage, daring to think, daring to do, fighting against wrong political views, daring to honestly recognize faults and weaknesses ... of a number of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta remains limited.

3.2. Causes and issues

3.2.1. Causes

3.2.1.1. Causes of advantages

Firstly, the achievements of the country's renovation in general, and of the provinces and cities in particular, have had a very positive impact on the political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta; *Secondly*, the policies and guidelines of the The Communist Party of Vietnam is correct and appropriate, especially in the cause of national renovation; *Thirdly*, the political and ideological education for cadres in general and cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta in particular has been given attention and has been innovated and improved in quality; *Fourthly*, the cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta always take the initiative in their activities and perform their duties and responsibilities well; *Fifthly*, studying and following Ho Chi Minh's ideology, morality, and style has become a common political activity throughout the entire Party, assisting each cadre under the management of the standing committees of provincial and municipal party committees in the Red River Delta to self-examine and reflect on themselves.

3.2.1.2. Causes of limitations

Firstly, the awareness and sense of responsibility of a number of party committees, party organizations, leaders of agencies, units, cadres and party members, including local leaders, agencies and units, regarding the building of political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta are not really

complete, profound and comprehensive, and the political and ideological education work has not been given due importance; *Secondly*, a number of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta have not really been exemplary in self-awareness and training of political bravery, some have fallen into individualism, bureaucracy and subjectivity; *Thirdly*, the negative side of the market economy has had a significant impact on the political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta; *Fourthly*, hostile forces carry out the strategy of “peaceful evolution” to shake the political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta;

3.2.2. Issues raised about the political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta

Firstly, the solid political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta require a steadfast political and ideological stance, wholehearted service to the Party's cause, and the preservation of Party principles and regulations, while their policies on remuneration and salaries have not yet met the living requirements of cadres and taken care of their families. *Secondly*, the construction of political bravery, the spirit of sacrifice for the Party and the people, requires a positive political and social environment, and the leading example of those who superior cadres, but currently, a large number of key leaders and senior leaders who say things that do not match their actions, say one thing and do another, are not exemplary, corrupt, negative, violate Party discipline and State laws and must be disciplined or criminally prosecuted. This has been affecting the trust and support for training and improving the political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta; *Thirdly*, most of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta have good qualities, professional and technical capacity, but due to the rapid and extensive changes of international integration, a number of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta lack economic management skills, state management skills, and skills in working in an international environment, so they are limited in decisiveness, daring to think, daring to do;

Summary of Chapter 3

In Chapter 3, the thesis clarified the current status of political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta with its advantages, shortcomings and limitations, and at the same time assessed the causes of those advantages, shortcomings and limitations. The thesis also mentioned the issues raised regarding the political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta at present, as a basis for proposing directions and solutions to improve the political bravery of this cadre group in Chapter 4.

Chapter 4

DIRECTIONS AND SOLUTIONS TO IMPROVE THE POLITICAL BRAVERY OF CADRES UNDER THE MANAGEMENT OF THE STANDING COMMITTEES OF PROVINCIAL AND MUNICIPAL PARTY COMMITTEES IN THE RED RIVER DELTA IN THE COMING TIME

4.1. Forecast and direction to improve the political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta in the coming time

4.1.1. Forecasting favorable and unfavorable factors affecting the improvement of political bravery of cadres under the management of the standing committees of provincial and municipal party committees.

4.1.1.1. Forecasting favorable factors

Firstly, international factors have many favorable impacts on improving the political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta; *Secondly*, the achievements after nearly 40 years of national renovation and the remarkable development achievements of the provinces and cities in the Red River Delta are the basic favorable premises affecting the improvement of the political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta; *Thirdly*, promoting the building and rectification of the Party and the political system associated with continuing to study and follow the ideology, morality and style of Ho Chi Minh will be carried out regularly and effectively and will be a favorable condition to improve the political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta in the coming time.

4.1.1.2. Forecasting difficult factors affecting the improvement of political bravery of cadres under the management of the standing committees of provincial and municipal party committees

Firstly, the negative impact of globalization, the Fourth Industrial Revolution, and the difficult development of the international communist workers' movement; *Secondly*, hostile forces continue to vigorously implement the strategy of “peaceful evolution”, attacking and sabotaging the ideology of cadres; *Thirdly*, the negative impact of the negative impact of the market mechanism and the integration process leads to complicated developments in the degradation of political ideology, ethics, and lifestyle of cadres and party members;

4.1.2. Directions

Firstly, building political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta today is aimed at building steadfast leaders in all aspects: People with a steadfast political bravery, loyal to the ideals, the path to socialism, the principles of Party building, people who represent revolutionary ideals, have infinite loyalty to the Party and the Fatherland, loyal to the ideals of the working class and the nation; *Secondly*, to ensure the implementation of the requirements to improve the political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta, need to focus on doing well a number of principled contents.

4.2. Major solutions to improve the political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta in the coming time

4.2.1. Raising awareness and responsibility of provincial and municipal party committees, political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta and party committees, party organizations at all levels as well as cadres and party members on improving the political bravery of cadres under the management of the standing committees of provincial and municipal party committees.

Firstly, party committees and organizations must manage and grasp all aspects of the situation of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta, especially regarding the issue of political bravery; *Secondly*, strengthen leadership and direction in implementing propaganda work on issues related to improving the political bravery of political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta; *Thirdly*, party committees and organizations must focus on improving the quality of party activities, innovating party cell activities, and strengthening the management of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta.

4.2.2. Firstly, promote the role and responsibility of the leader in deciding the results of assessment and classification; *Secondly*, deploy and implement regulations on revolutionary ethical standards for cadres in general and cadres under the management

of the standing committees of provincial and municipal party committees in the Red River Delta in particular in the new period; *Thirdly*, research, develop and promulgate specific contents of the political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta.

4.2.3. Innovate the content and form of education and training of political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta; focus on training and updating political theory, improving political capacity and leadership skills.

Firstly, continue to innovate the work of political theory education and training, focusing on both content and form, programs, textbooks, and teaching methods of political theory subjects; *Secondly*, train and practice political bravery education for cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta through strengthening practical activities; *Thirdly*, link training and practice with the tasks of individual supervision and inspection and supervision of organizations;

4.2.4. Promote self-awareness, training, and improve the political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta.

Firstly, each cadre under the management of the standing committees of provincial and municipal party committees in the Red River Delta needs to build self-awareness in studying and training; *Secondly*, cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta need to promote the role of self-training in ethics and political qualities; *Thirdly*, provinces and cities need to create a favorable environment for cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta to train and promote their political qualities; *Fourthly*, strengthen inspection and supervision work to promote self-awareness. To promote self-awareness in training the political bravery, inspection and supervision work must be carried out seriously and regularly; *Fifthly*, encourage the implementation of activities that combine theory with practice.

4.2.5. Promote the role of the political system in improving the political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta; gradually build and innovate appropriate salary policies.

Firstly, the provincial and municipal party committees in the Red River Delta need to strengthen leadership and direction of the Fatherland Front and socio-political organizations to strongly innovate the content and methods of operation in the direction

of linking with solving practical problems in localities, agencies and units; *Secondly*, the Fatherland Front and socio-political organizations of provinces and cities in the Red River Delta need to strengthen supervision and social criticism, creating an environment for cadres to practice political discipline and sense of responsibility to the people; *Thirdly*, promote the role of the Fatherland Front and socio-political organizations in participating in managing and supervising cadres at their places of residence; *Fourthly*, promote the role of the people in participating in building the political bravery of cadres under the management of the standing committees of provincial and municipal party committees;

4.2.6 Strengthen inspection and supervision work of party committees and inspection committees at all levels and promptly and strictly handle cases of political degradation.

Firstly, raise awareness and responsibility of party committees on the role and significance of inspection and supervision work to enhance the political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta; *Secondly*, promote the role of party committees and organizations in participating in the inspection and supervision of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta ; *Thirdly*, combine the inspection and supervision work of party committees and organizations with the inspection of the government for cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta; *Fourthly*, strengthen the inspection and supervision of the responsibilities and exemplary role of leaders in the fight against bureaucracy, corruption, waste and group interests.

Summary of Chapter 4

Based on theory and practice, in chapter 4, the author has identified the improvement of the Party's political bravery and level, intelligence, capacity and qualities of the cadres in general and cadres under the management of the standing committees of provincial and municipal party committees in particular in the new period as one of the important and urgent political tasks. With that meaning, the author has summarized the influencing factors and forecasts and directions for improving the political bravery of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta in the coming time; at the same time, he proposed 06 specific solutions to improve the political capacity of cadres under the management of the standing committees of provincial and municipal party committees in the Red River Delta in the coming time.

CONCLUSION
